
LEASE ACTIVITY STATISTICS 1

December 2020

The total amount of leasing companies' claims under financial and operational leases was BGN 4.308 billion (3.7% of GDP²) at the end of December 2020 compared to BGN 4.293 billion (3.6% of GDP²) at the end of December 2019. At the end of the fourth quarter of 2020 these claims increased annually by 0.4% (BGN 15.8 million) and remained broadly unchanged in comparison with the end of September 2020.

CLAIMS UNDER LEASE CONTRACTS





Financial lease claims amounted to BGN 4.087 billion at the end of the fourth quarter of 2020. They increased annually by 0.3% (BGN 12.9 million), while decreased by 0.1% (BGN 3.7 million) in comparison with the end of the third quarter of 2020. Their share in the total volume of claims under lease agreements at the end of December 2020 was 94.9% and remained unchanged in comparison with the end of the same month of 2019. The new financial lease agreements concluded during the fourth quarter of 2020 amounted to BGN 476 million. Compared to the fourth quarter of 2019 their volume decreased by 8.9% (BGN 46.2 million) and by 0.7% (BGN 3.2 million) compared to the third quarter of 2020.

Financial lease claims by type of asset. At the end of December 2020 claims under agreements for financial leases of *Cars* amounted to BGN 1.634 billion. Compared to the end of December 2019 these claims increased by 0.2% (BGN 3 million), while decreased by 0.3% (BGN 4.6 million) in comparison with the end of the third quarter of 2020. Their relative share in the total amount of financial lease claims at the end of December 2020 was 40% and remained unchanged compared to the end of the same month of 2019. At the end of the fourth quarter of 2020 the claims under agreements for financial leases of *Commercial and light commercial motor vehicles* amounted to BGN 1.282 billion. They decreased annually by 3.7% (BGN 49.5 million) and by 1.4% (BGN 17.8 million) in comparison with the end of September 2020. Their relative share in the total amount of claims of financial lease decreased from 32.7% at the end of December 2019 to 31.4% at the end of the same month of 2020. At the end of the fourth quarter of 2020 claims under agreements for financial leases of *Machinery and industrial equipment* were BGN 930 million, increasing by 9% (BGN 77.1 million) compared to the end of December 2019 and by 1.3% (BGN 12.2 million) in comparison with the end of September 2020. Their relative share increased from 20.9% at the end of December 2019 to 22.8% at the end of the same month of 2020.


FINANCIAL LEASE CLAIMS BY TYPE OF ASSET 3

Financial lease claims on residents by institutional sector. At the end of December 2020 financial lease claims on sector *Non-financial corporations* amounted to BGN 3.381 billion. They decreased by 0.1% (BGN 3.3 million) compared to the end of the fourth quarter of 2019, while they remained broadly unchanged in comparison with the end of September 2020. The relative share of claims on *Non-financial corporations* in the total amount of the financial lease claims on *residents* was 82.7% at the end of December 2020 compared to 83.1% at the end of December 2019. At the end of the fourth quarter of 2020 claims on sector *Households and NPISHs* amounted to BGN 690.6 million. The amount of these claims increased by 2.7% (BGN 18.4 million) compared to the end of December 2019, while decreased by 0.3% (BGN 1.9 million) in comparison with the end of September 2020. The relative share of claims on *Households and NPISHs* in the total amount of the financial lease claims on *residents* increased from 16.5% at the end of December 2019 to 16.9% at the end of December 2020.

FINANCIAL LEASE CLAIMS ON RESIDENTS BY INSTITUTIONAL SECTOR 3,4






Structure of financial lease claims. At the end of December 2020 claims with maturity of over 1 and up to 5 years amounted to BGN 3.061 billion decreasing annually by 5% (BGN 162.2 million) and by 1.8% (BGN 55.4 million) compared to the end of the third quarter of 2020. Their relative share in the total amount of financial lease claims decreased from 79.1% at the end of December 2019 to 74.9% at the end of the same month of 2020. At the end of the fourth quarter of 2020 the amount of claims with maturity of over 5 years was BGN 829.6 million. They increased annually by 32% (BGN 201.3 million) and by 6.5% (BGN 50.8 million) compared to the end of the third quarter of 2020. At the end of December 2020 non-performing claims⁵ amounted to BGN 111.8 million. They decreased by 16.8% (BGN 22.6 million) compared to the end of December 2019 and by 4.4% (BGN 5.1 million) in comparison with the end of the third quarter of 2020.

Operational lease claims amounted to BGN 220.9 million at the end of December 2020 increasing annually by 1.3% (BGN 2.9 million) and by 1.6% (BGN 3.5 million) compared to the end of the third quarter of 2020.

Sources of financing. At the end of December 2020 leasing companies' liabilities amounted to BGN 5.246 billion compared to BGN 5.154 billion at the end of December 2019. They increased by 1.8% (BGN 92.2 million) on an annual basis, while decreased by 1.2% (BGN 64.2 million) compared to the end of September 2020.

In the structure of liabilities, received loans prevailed. Their relative share decreased from 79.7% at the end of December 2019 to 79.5% at the end of the same month of 2020. The amount of received loans was BGN 4.172 billion at the end of the fourth quarter of 2020. They increased annually by 1.6% (BGN 64.2 million), while decreased by 1.3% (BGN 54.7 million) compared to the end of September 2020.

At the end of December 2020 loans with maturity of over 1 year were 89.5% of the total amount of received loans compared to 84.7% at the end of the same month of 2019. They amounted to BGN 3.732 billion at the end of December 2020 increasing annually by 7.3% (BGN 253.3 million) and by 1.5% (BGN 56.3 million) compared to the end of the third quarter of 2020.

In the structure of received loans those from residents prevailed and amounted to BGN 2.633 billion at the end of December 2020. They increased by 6.6% (BGN 162.1 million) annually, while decreased in comparison with the end of September 2020 by 2.4% (BGN 65.1 million). Their relative share in the total amount of received loans increased from 60.2% at the end of December 2019 to 63.1% at the end of December 2020.

Debt securities issued by leasing companies amounted to BGN 5.8 million at the end of December 2020. They decreased by 42.6% (BGN 4.3 million) annually and by 31.5% (BGN 2.7 million) compared to the end of September 2020.
